TERMS & CONDITIONS FOR RETAIL RESERVATIONS

The following Terms and Conditions apply to all bookings made on this website or with our reservations team. We kindly ask that you take a moment to read them prior to making a Booking.

BOOKING

Bookings are only confirmed once these terms and conditions have been acknowledged and the deposit or full payment is received. Once the deposit or full payment is made, we will send you a confirmation e-mail for your records.

While bookings are not confirmed, rates and availability are subject to change without notice.

CHARGES

The rates displayed on the website are per home, per night, for the specific property you are booking. Plus local and State taxes.

All bookings will be assessed \$75.00 of which \$25 is a processing fee and a non-refundable \$50.00 property protection plan that will cover you for accidental damages of up to \$1,000 which must be reported immediately to Casa Floridian to be covered. Failure to immediately notify Casa Floridian of damages will result in loss of coverage.

Please be advised that intentional damage or gross negligence are the responsibility of the guest and are not covered by the property protection plan.

FLORIDA STATE LAW - MAXIMUM OCCUPANCY:

2 people per bedroom, 2 more if there is a sofa sleeper.

Occupancy may not exceed what is posted for each home, which includes infants and children. In the event we find guests exceed the occupancy posted for each home, we reserve the right to evict guests from the property with no compensation or refund. The staff or agents of Casa Floridian may enter the premises in order to perform inspections, routine maintenance and/or repairs.

PAYMENTS

We accept the following methods of payment: Credit cards: Visa, American Express, MasterCard, and Discovery.

For reservations made more than 30 days prior to arrival, a \$325 deposit is required at the time of reservation. The balance is due 30 days prior to arrival. The reservation is not confirmed until your deposit is received. If payment is not received, your reservation will be cancelled and your deposit will be forfeited.

If you are checking in within 30 days, the full payment is due immediately.

Failure to comply with specified payment due dates, may result in cancellation of your

booking. We may treat the failure to pay as a cancellation by you of your reservation. Deposits made will be subject to our cancellation policies listed below.

CHECK IN & CHECK OUT

Check-in: from 4:00 pm on the day of arrival; check-out is by 10:00 am on the day of departure. Early arrival or late departure times may be available, subject to availability and additional charges may apply.

We will email final instructions including directions and check-in details, approximately 2 weeks prior to the arrival date.

In the interests of security and to prevent fraud, at the time of check-in, guests may be required to confirm their identity by providing their booking reference; their passport, identity card or driving license.

We will request your credit card details and your consent to use the card for any outstanding balance you may owe. This credit card number will be charged if items are stolen or damaged in the rental property. You will also be required to sign an authorization form prior to check-in. The property should be left reasonably clean. If the property is not left in a suitable condition, it may be necessary to charge the credit card for costs to cover extra cleaning or trash removal.

CANCELLATION POLICY AND NO SHOWS

All cancellation requests must be received and acknowledged by e-mail and are subject to the following penalties:

- · 60 days or more prior to arrival \$75 .00 Cancellation Fee.
- · 30-60 before arrival date = \$325.00 deposit will be Non-refundable.
