

## **Privacy Policy:**

Protecting your private information is our priority. This Statement of Privacy applies to [www.venturereimanagement.com](http://www.venturereimanagement.com) and Venture REI, LLC and governs data collection and usage. ### **Collection Of Your Personal Information**
